#### THE EFFECT

RESEARCH TELLS US THAT THE ADVERSE LONG AND SHORT TERM BEHAVIORAL AND EMOTIONAL EFFECTS ON YOUTH EXPOSED TO TRAUMA ARE VAST INCLUDING BEHAVIORAL, SOCIAL, AND EMOTIONAL PROBLEMS, AS WELL AS COGNITIVE IMPAIRMENT MATERIALIZING THROUGH POOR GRADES, LIMITED PROBLEM-SOLVING SKILLS, AND SHORT ATTENTION SPAN AND FEELINGS OF GUILT, SHAME, WORRY, WORTHLESSNESS, SADNESS, AND ANGER. YOUTH LIVING WITH VIOLENCE IN THEIR HOMES OFTEN EXHIBIT PHYSICAL AND/OR BEHAVIORAL RESPONSES INCLUDING HEADACHES, STOMACH ACHES, SLEEP DISTURBANCE, INABILITY TO CONCENTRATE, SOCIAL WITHDRAWAL, ACTING OUT, AND ANXIETY. WHEN YOUTH ARE RAISED IN ABUSIVE HOMES MANY COME TO BELIEVE THAT VIOLENCE IS AN EFFECTIVE WAY TO RESOLVE CONFLICT. AMONG YOUTH EXPOSED TO VIOLENCE IN THEIR HOMES, GIRLS ARE TWICE AS LIKELY TO BE VICTIMIZED IN THE FUTURE AND BOYS ARE MORE THAN TWICE AS LIKELY TO BECOME PERPETRATORS OF ABUSE.

THE MORE TRAUMA A CHILD EXPERIENCES OVER TIME, THE MORE DIFFICULT IT BECOMES TO CONTROL TRAUMA RESPONSE. THEREFORE THE CHILD CAN NO LONGER ESTABLISH THE DIFFERENCE BETWEEN THREATENING AND NON-THREATENING SITUATIONS. A CLASSIC EXAMPLE OF THIS PHENOMENON IS WHEN A TRAUMATIZED
